The applicant proposes to replace a previously permitted 666 SF docking structure with a 531 SF permanent dock of the same configuration, install a new boatlift and watercraft lift and repair damaged breakwater.

Referencing the Robert J. and Helen L. Conrad Standard Dredge & Fill application, Tax Map 242-8, the Wolfeboro Conservation Commission questioned whether the boatlift would impact the viewshed since the boatlift is not seasonal and questioned the height above mean water level of the boatlift. The Commission contacted the applicant and continued its review until their 10/8/18 meeting.
