The applicant proposes to rebuild the existing crib dock and replace three tie-off piles and install a 14'x30' seasonal canvas canopy, two seasonal PWC lifts and a seasonal boatlift; 2' wide finger pier to be removed.

The Wolfeboro Conservation Commission noted no objection to the Lori Grayson Revocable Trust Standard Dredge & Fill application, Tax Map #259-35, as submitted.

The applicant proposes to remove the existing "U" shaped dock which was installed contrary to the permit and construct a "U" shaped seasonal crank-up dock with a 14'x30' seasonal canvas canopy to provide a total of 3 boatslips and repair existing perched beach retaining walls "in-kind".

The Wolfeboro Conservation Commission noted no objection to the 1994 S. Ballentine Family Trust Standard Dredge & Fill application, Tax Map 228-44, as submitted.
