

**Wolfeboro Police Commission
Meeting Minutes
May 18, 2017**

Members present: Chairman Steve Wood, Vice-Chair Joe Balboni Jr. and Ron Goodgame.

Staff present: Chief Rondeau, Captain Livie and Recording Secretary Amelia Capone-Muccio.

Chairman Wood called the meeting to order at 4:06 PM and introduced the Commissioners, staff in attendance and noted a quorum was present. He noted this meeting would include reporting from both March and April, since there was no Police Commission meeting in April.

➤ ***Pledge of Allegiance***

Chairman Wood entertained the Pledge of Allegiance.

Consideration of Minutes

- ***Public minutes of March 16, 2017 meeting.***

Commissioner Joe Balboni Jr. moved the Wolfeboro Police Commission to accept the public minutes of March 16, 2017 as submitted. Commissioner Ron Goodgame seconded. Members voted and being none opposed, the motion passed.

Activity Reports-March

Chief Rondeau reported on the following activity reports for the month of March:

Offenses (State Law) by month: He reported 50 offenses for the month.

Arrest status report: He reported a 27% increase from the previous month.

Personnel Analysis report: The report is a synopsis of each officer's reporting for the month.

Accidents by street name: He reported 12 accidents last month, which is a 14% decrease from the previous month.

Prosecutor's report: Provided for review.

School Resource Officer (SRO): The SRO provided his monthly report noting numerous investigations for the month.

Motor Vehicle Traffic Report: He reported 76 stops last month at 36% decrease. He noted out of those only 8 resulted in tickets and \$1,392.00 in fines.

Detectives Report: He reviewed the Detective's report noting that 33% of the cases have been closed, which is great work by Detective Maloney. He took on 6 new cases for the month.

Central Dispatch: He reported calls for service are slightly up over last year.

DISCUSSION:

Commissioner Goodgame questioned the status of the Center Street reconstruction process.

Captain Livie replied that they have been in communication with the Public Works Department and the bulk of the project will take place in August and September and the public will see some detours.

Commissioner Goodgame questioned if officers are still investigating cases.

Chief Rondeau replied they do, otherwise the Defective's caseload would be backlogged.

Commissioner Goodgame suggested they need to review that information to determine the future needs of the department. He stated a review of the utilization of the department's assets are needed to determine if they are being utilized in a proper manner as the goal is to streamline the department and get what is needed for the department and advocating through the Board of Selectmen and Budget Committee process.

Chief's Items for March

Chief Rondeau reported the following:

- He noted he has two non-public items for discussion under personnel and litigation.
- He stated as many know Sgt. Keaton was selected as the new Chief of Police for Bartlett and that Wolfeboro's loss is Bartlett's gain. The department wishes him well in his new role.
- Officer Beaulieu has completed the hiring process and in field service training.
- The two seasonal officers have been selected and will begin training to start in June.
- He and the Captain held a staff meeting and a separate meeting for dispatch.
- He and the Captain continue to attend Board of Selectmen meetings and also covered the primary election.
- The department plans to bring back the Bike Patrol this summer.
- There will be increased patrols for speed and DWI patrols with the help of grant funding during the busiest months.
- He noted some officers and dispatch employees attended training this month and all officers attended in service training.
- He noted the new WCTV cable channel show called Coffee and Connections with the Chief is where members of the public can meet for coffee with the Chief and Captain and discuss any issues, questions, or concerns over coffee. Please contact WCTV at 569-0219.
- He reviewed the Police, Central Dispatch and Animal Control budget status noting expenditures to date are where they need to be for this time of year. He noted that he, the Captain and Administrative Assistance review the budgets every 10 days.

DISCUSSION:

Commissioner Goodgame questioned the overtime line.

Chief Rondeau replied that was due to staffing, without full staff due to transfers in positions. He noted that they will also see some relief when the summer officers are on duty.

Commissioner Goodgame questioned if the summer positions will help with the 2:00 shift.

Chief Rondeau replied he believes it will.

Activity Reports-April

Chief Rondeau reported on the following activity reports for the month April:

Offenses (State Law) by month: He reported 79 offenses for the month, a 45.9% increase.

Arrest status report: He reported 31 arrests for the month a 34% increase from the previous month.

Personnel Analysis report: The report is a synopsis of each officer's reporting for the month.

Accidents by street name: He reported 6 accidents last month, which is a 50% decrease from the previous month.

Prosecutor's report: 15 defendants responded to 19 charges this past month, 10 plead or were found guilty, 6 charges were placed on file pending good behavior, one nolle pross case and one defendant was sent back to the NH State Prison for the remainder of her sentence for transporting drugs in a motor vehicle.

School Resource Officer (SRO): The SRO provided his monthly report noting numerous investigations for the month.

Motor Vehicle Traffic Report: He reported 228 stops last month at 200% increase. He noted out of those only 14 resulted in tickets.

Detectives Report: He reviewed the Detective's report noting that 75% of the cases have been closed, which is great work by Detective Maloney. He took on 8 new cases for the month.

Other: He provided a new report this month which provided the average speed for a ticket, which is 16 over the limit, for example the speed limit is 30 mph and the vehicle was clocked at 49 mph, which is too fast for this zone.

Chief's Items for April

Chief Rondeau reported the following:

- Two items for non-public carried over from last meeting for personnel and litigation.
- The exam for the Sergeant position has been sent to those interested and results are due back to the Captain on May 19th. Oral Boards begin June 14th for the Police Board and June 20th for the Police Commission.
- The seasonal officers; Christopher Dustin and Garrett Anthony have been sworn in and are in the FTO process. They will begin covering downtown in June.

- The Bike Patrol is equipped with some new gear and after 12 years the patrol will be hitting the streets once again. Sgt. Archambault will begin patrols and officers Swift and LaRoche will join the patrol once they attend training in York ME.
- He and the Captain conducted a staff meeting in April.
- Operational grants have begun and the public will see an increase in patrols due to federally funded grants for DWI, Speed, distracted driving and pedestrian and crosswalk.
- He reported the officer's training for the month and all dispatch completed a 3-hour in-service training.
- He and the Captain continue the program Coffee and Connections with WCTV.
- The next town election is scheduled for May 23rd at Town Hall.
- The Department and Commissioner Goodgame met with members of the Master Plan Committee.
- He and the Captain met with the Fire Chief regarding emergency planning and regarding the next Public Safety Open House on July 1st, 2017.
- He noted the department has had some press releases on successfully closing some major investigations. He stated the Wolfeboro Police Department reminds the public to voluntarily comply with the law.

Captain's Items

Captain Livie reported the following for the month:

- April is National Distracted Driver Awareness month and they will be doing extra patrols with the help of grant funding. He reminded the public that the first offense for the Hands Free Device law is \$124, second offense is \$310 and 3rd offense is \$630.
- The radar unit was deployed today and will be out for the season. He reminded the public if you have a concern of speed issues in an area to call the department.
- He thanked Nordic Skier for servicing the bikes for the bike patrol for 3 officers this season.
- He noted that grants have been submitted for 8 mobile data units for the cruisers, this provides the ability to scan a license making traffic stops more efficient.
- Public Safety Open House is scheduled for 7/1/2017 12:00 PM to 2:00 PM and this will be the same as last year collaborating with the Fire Department. He noted this year there will be an auction of bikes that have been accumulating and unclaimed.
- He read some letters of thanks for some of the officer's efforts for the public's information.

Commissioner's Items

Chairman Wood noted that due to a scheduling issue the Police Commission meeting will be held on June 22nd, 2017 at the Wolfeboro Public Library, instead of June 15th. He noted the Commission voted to adopt the Rules of Procedure at their last meeting and they have a copy to sign. The document will be on the Town website and recorded with the Town Clerk (see attachment). He stated that the document was created to provide more clarity on how Police Commission meetings are conducted and how the public may communicate with the members. Member of the public Joe Melanson canceled his request this evening as he could not make the meeting.

Board of Selectmen's Representative

Public Comment

Being no further business before the Commission, Chairman Wood entertained a motion to enter non-public session to discuss personnel (hiring of officer) and ongoing litigation.

Commissioner Joe Balboni Jr. moved the Wolfeboro Police Commission enter non-public session RSA 91 A: 3 a, b & c to discuss personnel and ongoing litigation at 5:28 PM. Joe Balboni Jr. seconded. Roll call vote: Ron Goodgame- yes, Joe Balboni Jr.-yes and Steve Wood-yes, the motion passed.

The Commission re-entered public session at 5:53 PM.

Commissioner Ron Goodgame moved the Wolfeboro Board of Selectmen to seal the minutes of the May 18, 2017 non-public meeting. Joe Balboni Jr. seconded. Roll call vote, Chairman Wood– yes, Ron Goodgame – yes, and Joe Balboni Jr. – yes. Being none opposed, the motion passed.

Being no further business before the Commission, Chairman Wood entertained a motion to adjourn.

Commissioner Joe Balboni Jr. moved the Wolfeboro Police Commission to adjourn at 5:54 PM. Commissioner Joe Balboni Jr. seconded. Being none opposed, the motion passed.

Failure to head the guidelines specified could result in censure from the Chair or other ramifications set forth by the Police Commission members.

RULES OF PROCEDURE WOLFEBORO POLICE COMMISSION WOLFEBORO, NH

SECTION I: PURPOSE:

These Rules of Procedure describe the duties, mechanics and methods of operation for the Wolfeboro Police Commission while prescribing general rules of conduct for its members.

SECTION II: ORGANIZATION:

The Wolfeboro Police Commission is a three member board which was authorized by State Chapter 377, Laws of 1959, and was established by vote of the March 1960 Wolfeboro Town Meeting. Its broad duties and responsibilities are outlined under that Act. Additionally, NH RSA 105-C entitled "Police Commissions" and its paragraphs provide additional guidance, but have not been adopted by the Town of Wolfeboro, NH.

A.) DUTIES and RESPONSIBILITIES OF MEMBERS:

1. All members shall make every effort to attend each scheduled meeting. The Chair should be notified by Commissioners of an impending absence prior to the meeting. All members of the Commission will conduct their work on the Commission and their duties in accordance with these guidelines and the NH Legislative Act of 1959 (Chapter 377, and its supplements and amendments) authorizing the creation of the Wolfeboro Police Commission and any other applicable NH laws.
2. Members of the Commission have authority only when acting as a Commission legally in session. One Commission member has no authority and cannot speak for the Commission except when representing the voted position of the Commission. Members of the Commission have authority only when all actions are voted on by the majority of the Commission at a public meeting that complies with the Right to Know Law RSA 91-A. The Commission shall not be bound by any action or statement of an individual member, except when such statement or action is pursuant to instructions voted on by the Commission.
3. Members are expected to be available to sign such reports and paperwork as necessary and authorized (unless impending absence has been noted).
4. Members are expected to come prepared to meetings with the understanding that the minimum requirement is to read the meeting packet ahead of time. It should be noted that that the Commission is not designed or designated to micro-manage the daily affairs of the Chief of Police or his employees, but rather to oversee the smooth operation of the Police Department and its components, see to the hiring and firing of personnel and the setting of their compensation

and serve as a liaison from and to the public and the other boards and commissions of the Town of Wolfeboro NH as may be required.

5. The Wolfeboro Police Commission members are not Police Officers and do not have authority to arrest or investigate crimes or administrative complaints in the Town of Wolfeboro; they are not licensed to do so; however, inasmuch as the Commission has ultimate authority over the termination of police officers and others under the command of the Chief of Police, the Commission shall be privy to all internal affairs investigations and complaints levied against the Chief and those under his/her command. Though Commission members may hear criticisms from citizens about various issues regarding the Police Department, complaints, or misconduct centering on the Police Department, its components, or its employees, those complaints may only be investigated by the Chief of Police, his designate, or an outside agency; as such, all complaints received by the Commission will be turned over to the Chief of Police for examination. If deemed appropriate those inquiries will be conducted in the form of an internal affairs investigation. All such internal affairs investigations will be handled by the Wolfeboro Police Department or referred to an outside agency such as the County Attorney, or the NH Attorney General's Office who will conduct the inquiry in a manner in accordance with NH State Law. Internal Affairs investigations will always be conducted in a custom which insures due process. Upon completion of any internal affairs investigations returned as "sustained" the Commission has the authority to hear matters for discipline, suspension, and or termination. It is for this reason that the Commission must refrain from investigation of those reported matters, and remain fair and impartial as the adjudicatory hearing authority and not the investigatory agent.

6. Members are expected to attend assigned committee and cross-over meetings if assigned. When unable to attend meetings, members should notify the Chair (in time to arrange alternate coverage if possible).

7. The duties and responsibilities of the Wolfeboro Police Commission were established pursuant to the authority of New Hampshire Legislative Act 377 of 1959 and its supplements and amendments. As set forth therein it shall be the duty of the Police Commissioners to appoint such police personnel as they deem necessary and to fix such persons' compensation. The Commissioners shall make and enforce all rules necessary for the operation of the police force in the manner most beneficial to the public interest. The Commissioners may at any time remove any of the aforesaid personnel for Just Cause and only after a hearing satisfying the requirements of due process, which Cause shall be specified in an order of removal.

8. Commission members are paid a stipend for serving much like that of other elected officials serving in the Town of Wolfeboro. This compensation is set by 1959 Legislative Act 377, as amended. No other form of reimbursement or compensation is allowed (Commission members are understood to be acting and serving in their civil capacity and performing a civic duty while fulfilling a civic responsibility) unless budgeted for by the Commission, and voted upon by its members in advance. Likewise, travel reimbursement is especially NOT authorized unless specifically permitted by the Commission (in advance) and approved by the Chief of Police and Town Manager in accordance with Town Policies and procedures for such travel.

9. Unless waived and approved by the full Commission in advance, Commission members are prohibited from doing business with the Wolfeboro Police Department or its components under the concept of "conflict of interest(s)."

10. Commission members may only cause expense to the Wolfeboro Police Department or its components by a vote of the Commission. Individuals engaging in acts likely to cause expense, or requesting unauthorized Commission services such as telephone meetings or conferences with Town Counsel, for example, are not authorized, unless specifically directed by the Chair and voted upon at a regular meeting. Any violation of this rule may subject the offending member to full reimbursement of the expense to the Town of Wolfeboro Police Department.

B.) OFFICERS OF THE COMMISSION:

1. CHAIR: A Chairperson ("Chair") shall be elected at the first regularly scheduled meeting following the swearing in of members elected at the annual Town Meeting. Election shall be by a majority vote of those present. The Chair shall preside at all meetings of the Commission and perform all duties required by law and in accordance with Robert's Rules of Order and these Rules of Procedure. The Chairperson's duties are as follows:

- a. To open the session at the time at which the Commission is to meet by calling the members to order.
- b. To announce the business before the Commission in the order in which it is to be acted upon.
- c. To recognize members entitled to the floor. After recognition, questions accepted from the public shall be addressed through the Chair after they identify themselves and their residence.
- d. To state and put to vote all the questions which are regularly called or necessarily arise in the course of the proceedings, and to announce the result of the vote.
- e. To protect the Commission from annoyance and to ensure generally that the Commission follows the accepted and practiced rules of order.
- f. To assist in expediting all business in every way compatible with the rights of the members by:
 - aa) Allowing remarks when non-debatable motions are pending.
 - bb) Calling a recess to permit restoration of order or clarification of an obscure point if she/he thinks it advisable.

- cc) Guiding the members when engaged in a debate to stay within the rules of order.
- dd) Ensuring on all occasions the observance of order and decorum among the members.
- ee) Deciding all questions of order (subject to an appeal by any two (2) members) unless he or she prefers to submit the question for the decision of the Commission.
- ff) Informing the Commission on a point of order, or practice pertinent to pending business.
- gg) Recognizing Commission member's requests for disqualification from issues where a conflict of interest may occur, as well as abstentions from voting.
- hh) To authenticate by his/her signature, when necessary, all acts, orders, and proceedings as directed by vote of the Commission.
- ii) The Chairperson shall vote as a member of the Commission, and may offer a motion or second a motion when necessary and appropriate.
- jj) Discussions which are not addressing the business before the Commission, or which are conducted in a disorderly or disrespectful manner, shall be ruled out of order. The Chairperson shall take whatever action is necessary to achieve and maintain order, including ordering the removal of any person who continues disorderly conduct.
- kk) Correspondence shall be directed to the Chair of the Commission, and Communications from the Commission shall be signed by the Chair or designee. An Annual Report shall be prepared by the Chair and submitted to the Annual Report of the Town.

2. VICE-CHAIRMAN: If desired by the Commission, a Vice-Chairman may be elected at the first regularly scheduled meeting following the swearing in of members. Election shall be by a majority vote of those present. The Vice-Chairman shall preside at all meetings that the Chairman is unable to attend or when the Chairman is recused from sitting upon or hearing a particular matter.

C.) COMMITTEES: The Commission, by vote, may delegate members to serve on committees and to perform other duties.

1) The Chair shall request from members their choices of committees, boards, and commissions they wish to serve on as Commission Representative's if required by the Chair.

2) The term of all appointments of Commission Representatives, shall be for one (1) year, or until replaced.

SECTION III: OPERATION OF THE COMMISSION

A.) MEETINGS:

1. **ORGANIZATIONAL MEETINGS:** An organizational meeting to elect officers shall be held in accordance with Section II, A). The Commission shall establish a schedule for the upcoming year. It is understood that Wolfeboro Police Commission meetings are held on the third Thursday of each month at 1600 hours (4:00P.M) unless otherwise modified by the Commission with additional meetings scheduled as needed.

2. **REGULAR MEETINGS:** A more formalized meeting of the Commission generally conducted (unless otherwise adopted by the Chair) in accordance with the format of the "Agenda" (attached hereto as Appendix A and by this reference incorporated herein). See also Agenda discussion **SECTION IV** herein. Generally accepted Robert's Rules of Order are hereby adopted. Those in attendance are reminded to act and dress according to the decorum which is required at these meetings.

3. **NON-PUBLIC MEETINGS:** A meeting of the Commission, or a portion thereof, held for Personnel and/or other excepted issues in accordance with RSA 91-A:3 and other relevant RSAs.

B.) SCHEDULE OF MEETINGS: Unless otherwise noticed, the Commission shall meet the third Thursday evening each month in a Regular Meeting commencing at 1600 hours (4:00 P.M). Each meeting shall be posted in accordance with RSA 91-A. The Agenda for such meeting shall be posted Not Later Than ("NLT") one week in advance of the meeting; however failure to do so shall not be cause to invalidate any action taken at the meeting. Citizens wishing to discuss topics NOT on the Agenda shall notify a Commissioner, the Chief of Police or the Captain in writing with the specific topic to be discussed in order to schedule same at the meeting NLT 48 hours before each session in order that the Commissioners may prepare for proper discussion, scheduling and handling of the topic in a judicious manner avoiding, to the extent possible, unanticipated questions, concerns, and/or debate and matters which are inappropriate for a Regular Meeting. Failure to do so may result in the requested agenda time being denied by the Chair. Additionally, it is understood that the Chair is not obligated to allow for public discourse or agenda time to members of the public under NH RSA 91-A. When allowed to speak either in a public session or on an agenda topic, citizens are required to keep their comments limited to five minutes with extension granted to them by the Commission through exception on a case by cases basis. Nothing in this paragraph is meant or intended to limit the public from asking questions through the Commission on matters being presented. Additionally, if members of the public wish to be heard on the Agenda it is in their best interest to request to be on the Agenda at least one week ahead of the scheduled meeting to allow the Commission Secretary to include the subject's name and topic on the Agenda list; failing to meet this suggestion may result in

information being left off or not included since the Agenda is usually posted one week in advance.

C.) REPORTS OF COMMITTEES: Written reports from committees received by the Commission, if any, shall be filed with the Town Clerk. Oral reports will be at regular meetings after the Chief of Police report.

SECTION IV: RULES OF ORDER:

A.) QUORUM: A quorum shall consist of two (2) members of the Commission.

B.) AGENDA: An Agenda shall be published with meeting notice, and included in the minutes. A suggested topical agenda is provided below. See also Appendix "A". It may be changed by the Chair or by a vote of the Commission at the meeting, as in a motion to strike or table an item from the Agenda. Listed below are the topics and in the order as to which generally the Wolfeboro Police Commission meetings may follow. This may be changed from time to time by the Chair at his or her discretion and without vote or notice. (See Appendix A for an example of a typical Commission agenda). The Agenda may or may not contain the name of individuals wishing to speak "on agenda" at a meeting.

1. Approve minutes
2. Chief of Police Report
3. Commission Business
4. Old Business/Tabled and Pending.
5. Selectmen Rep input/comment
6. Agenda items/Public Input (Public Input (limited to 5 minutes per person and not more than 15 minutes in total on the Topic without leave from the Chair.)
7. Questions from the Press
8. Non-public(s), if necessary
9. Adjournment

C.) CONDUCT OF MEETINGS: Meetings shall be conducted in accordance with generally accepted practices of order and decorum. In the event of a dispute regarding procedural matters, Robert's Rules of Order shall serve as a guideline with a vote of the Commission being the final deciding authority. During the meeting the Chair may deem any citizen "out of order." Additionally, The Chair, or the Commission may deem a frequent speaker at the meetings to be vexatious or harassing if, in the opinion of the Commission, or the Chair, that the speaker's attitude, demeanor, inflection, and general discourse brings no new, insightful, or otherwise meaningful discussion to the Commission's attention. Persons deemed vexatious or harassing may have their speaking ability limited at future Commission meetings.

D.) RECORDING OF VOTES: Votes shall be by voice, show of hands, or by a roll call as required by law as, for example, voting to go into nonpublic meeting must be by roll call. The vote of each member present shall be recorded.

E.) REQUESTS FOR INFORMATION:

1. Should it become apparent to the Chair or an individual Commission member, in the interim between meetings, that additional information relative to a specific item may be needed for Commission use at the next regularly scheduled meeting, a request for this information may be submitted to the Chief of Police who will obtain it or speak with the other Commission members and retrieve and send out all the information requested to all members.
2. Request for information from the public pursuant to the "Right to Know Law" otherwise known as 91-A will be processed in a manner consistent with that law and other applicable State and Federal statutes. These request(s) are of course subject to the fees and costs allowed to the maximum permissible under that statute (91-A) and other NH State and Federal Statutes, policies and practices.

F.) RECUSAL OR DISQUALIFICATION OF MEMBER: No member of the Commission shall participate in deciding or sit upon the hearing of any question which the Commission is to decide in a judicial capacity if that member has a direct personal or pecuniary interest in the outcome which differs from the interest of other citizens, or if that member would be disqualified for any cause to act as a juror upon the trial of the same matter in any action at law. Reasons for disqualification do not include exemption from service as a juror or knowledge of the facts involved gained in the performance of the member's official duties. In this matter the Commission refers to NH RSA 673:14 II as guidance, and everything it infers, including, but not limited to matters concerning undue influence and conflicts of interest.

SECTION V: EMPLOYEES.

A.) DUTIES: The Commission's secretary, or his/her designee as approved by the Chair, shall be responsible for recording the minutes of the Commission's meetings (to conserve paper, two-sided printing is encouraged), and an official copy of the records is to be filed in the Town Clerk's Office and on the Town's website open to inspection by any person at reasonable times. The secretary shall record not less than the following:

1. The type of meeting
2. Time and place of meeting.
3. The presence/absence of Commission members.
4. Whether the minutes of the previous meeting were approved or amended.
5. A brief, written report of the general topics discussed.
6. All main motions and points of order and appeals, whether sustained or lost, and all other motions that were not lost or withdrawn.
7. Record of any votes by the Commission, including names of those members opposed if not unanimous.
8. The hour of adjournment.

SECTION VI: AMENDMENT PROCEDURE



A copy of any amendment shall then be certified and submitted to the Commission's secretary for inclusion in the Commission's records.

SECTION VII: EFFECTIVE DATE




