> Forgotten Farms

Chairman Strauch stated she had friends that were involved in the event. The event was at the music hall on April 27<sup>th</sup> in Portsmouth. Chairman Strauch discussed showing the movie in Wolfeboro with the director and producer when she attended the event.

Vice Chairman Silk stated there are other options besides using the Great Hall to show the movie. The Village Players Theater and Brewster's Anderson Hall were options the Commission could look into using for showing the movie.
