A. Approval: Hawkers & Peddlers Permit location #4- Wolfeboro Boat Co.

Liz Hartford spoke to the request of putting a cart, to sell items representing Wolfeboro

- L. Murray asked about obtaining the license for this.
- L. Harford said yes.

B. Approval: Emergency Management Deputy Position-

Fire Chief Zotti spoke to the need of appointing a Civilian member to become an Emergency Management Deputy. Senior Staff Members are needed in the field. B. Deshaies asked if this would be an unpaid position, Chief Zotti said yes and eventually budget for a small stipend.

L. Freudenberg moved to approve appointing an EMD as outlined by Chief Zotti. B. Deshaies seconded the motion, all in favor, motion passed.

C. Approval: Arbor Day proclamation- May 6th, 2022- Parks & Recreation

Chairman Murray read the Proclamation Declaring May 6, 2022 Arbor Day

B. Harriman moved to declare Arbor Day May 6, 2022, motion seconded, all in favor, motion passed

D. Appointment: Dan Ross-Pleasant Valley Road condition

Mr. Ross, addressed the Board with concerns regarding the current condition of Pleasant Valley Rd. Mr. Ross feels the condition of the road is deplorable and would like the Board to consider appropriating funds to repair the road.

Mr. Nobel endorses Mr. Ross's comments, wanted to add the runoff of water that hasn't been seen before and feels this run off is adding the negative issues of the road.

Mr. DeVylder also spoke to the negative condition of the road. He would not like to wait 2 years for repair.

Inaudible residents (2), spoke to the how the money is being spent in the Town, but ignoring the needs of the road. Feels like its time for PVR to get attention.

B. Budman Inquired about the safety of the road. Board voted to make precautionary repairs. Would like to consider moving forward to repair please consider implementing recreation and running on it.

Lauren Sealy spoke to the dangers of bicycling on the road.

Mike Matos asked the board to consider speaking to the residents before moving forward with repairs as they know the road well.

Sandy Wing spoke to pedestrians, bikes, cars, are all effected in the use of the road, the road has bad drainage. Every year the road gets worse.

Chairman Murray also spoke to the condition of Pleasant Valley Road, and possible solutions. She noted that back in 2019 a list of roads needing attention and Pleasant Valley was on the list for 2020-2021.

B. Harriman moved to have Item G moved up on the Agenda moved. Senecal seconded the motion, motion approved.

E. Approval: Emergency Road work approvals-Public Works

Town Manager Pineo said the town invests 1.3 million a year to put into our roads, and the costs only rising. We have a chance to use ARPA funds for emergency repairs on Pleasant Valley Road and that would be all we could do this year. We could come in with a Warrant Article in 2023 for Pleasant Valley Road work.

Chairman Murray invited Dave Ford to speak regarding the issue.

- D. Ford spoke to the residents' comments regarding the condition of Pleasant Valley Road, he apologized for the condition of the road and stated he is embarrassed, he praised his crew for the work they do in helping keep 66 miles of roads up to date within the Budget we work with. He said it will be costly to replace the road that the residents envision.
- L. Murray stated that some parts of the road are worse than other sections, and possibly could be done in sections.
- J. Pineo mentioned a stand-alone Bond Project as a possible solution.
- L. Murray doesn't believe that would work.
- D. Ford gave a further description of his proposal. He summarized his the original road plan this year, but how he could revise that to incorporate some repairs to

Pleasant Valley. He noted that an emergency fix will be what they would address first then a plan to address the rest of the issues which is a total of \$420,000 in repairs. He suggested that this emergency work could be funded with ARPA funds.

- B. Harriman commented on suggested solutions and agrees with what he proposes to do that the suggestions and economical for the future larger project.
- B. Deshaies asked the audience for a show of hands on how they voted on two Warrant Articles.
- L. Murray asked D. Ford about the process involved on his proposal.
- D. Ford addressed the process in depth and the scope of the project and the most cost effective approach. It is a scenic road, with a lot of ash trees are dying. He's like to know if the Board would like to go with this proposed plan.
- L. Freudenberg agreed with Mr. Harriman, there are miles of roads that Wolfeboro takes care. He thinks they should address the emergency but the full project will need to come forward which will be expensive.
- D. Senecal explained to the audience that the BOS is not the only Board to look at these issues, the CIP and Budget Committee are also involved.
- D. Ford proposed a work session with Pleasant Valley residents to discuss it further.

A few Pleasant Valley residents spoke to D. Ford and wanted him to know this was not an attack of him and his crew, they have done a great job on the roads in Wolfeboro. The purpose of the comments, they just wanted to make clear the road was in dire need of repair and is becoming a safety issue. The residents like the idea of a workshop and the ability to work together.

- L. Murray clarified they are talking about proposal that includes Rt. 28 to New Garden Rd (no bridge), Upper Trask and Pleasant Valley Culvert, and in house work on Pleasant Valley for a total of \$420,000.
- Mr. Ford replied correct.
- B. Harriman moved to appropriate \$420,000 from ARPA funds as outlined in memo dated from Dave Ford to be used for repairs to Pleasant Valley Road and Upper Trask Mountain Road as proposed. Senecal seconded; all in favor, motion passed.

F. Approval: ARPA Grant Funding use updates-Public Works

Dave Ford addressed the ARPA Funding from his memo dated 3/28/22. The Town has received half of the \$640,000 in ARPA monies expected. He noted a bulk of the funds will be used as discussed for Pleasant Valley Road, the remaining funds he proses to use follows:

Underground pipe replacement in center of town (around Town Hall).

- Sewer Pump Station in need of new control handles.
- o New Truck for DPW, had to move quickly, the costs where escalating.
- o Sewer Ext. suggested for Varney Rd.
- Sewell Rd to Forest Rd (Carey Beach) sewer project.
- L. Murray questioned is the concern the phosphorus getting into the lake, and she needs to see what you are looking at and plan sooner than later so she can understand what is happening.
- D. Ford said he could get her a memo to clarify that, but we need to get going on this project due to the timing.
- B. Harriman, said he is comfortable with this work, he has spoken to Dave about this issue. He would like to see people come off their sewer and on septic.
- D. Ford said these plans will need to be looked at by the state.
- D. Senecal would like to see the Plan, and asked D. Ford to forward them to him as soon as possible. He has a meeting with NH DES next week.
- B. Deshaies asked if the Bath Houses at Carey Beach will be in use this summer.
- D. Ford said yes.
- L. Murray entertained a motion and noted that it will be contingent upon getting that sewer line plan as practical

D. Senecal made a motion to approve the requested amount of \$640,000 from the ARPA funding as recommended. Motion seconded by B. Harriman, all in favor motion passed.

G. Approval SRF Port Wedeln Drainage Project-Consultant Selection

Mr. Ford stated this project includes Port Wedeln and a small portion of the private association. It was put out to bid reviewed by staff, interviewed three companies. The company chosen was Stantec due to their history with us and ability to work on this large project. He provided a list of the consultants used by the Town so we can prove the consultants were chosen based on qualifications.

L. Murray stated it is a nice list to have and that is what the state does.

H. Approval: Seasonal Water Line Connection fees for upgrades

- D. Ford addressed topic previously discussed at other meetings; the need to update the Water and Sewer Rate Schedule to include the summer lines. It will not fully recoup the cost but helps to offset the cost and is a compromise to get this very important project done D. Ford recommended the following:
 - Private Year round No Fee
 - Municipal Seasonal \$3,000/3bedroom or less
 - No service \$6,000/3 bedroom or less
 - Note: Additional \$1000/bdrm. For seasonal; \$2,000/bdrm for new customers

B. Harriman made the motion to approve the New Water Fee Schedule effective April 6, 2022 as presented. B. Deshaies seconded, all in favor, motion passed

I. Discussion: Feasibility Study-Municipal Electric Building, Lehner Street

- D. Ford spoke to the Feasibility Study performed by Bergeron Technical Services.
- D. Ford Feels there is good vision for the building.
- L. Murray suggested getting CCI involved to get another perspective for uses.

J. Discussion: Progress of Master Plan recommendations

L. Murray spoke to the Master Plan recommendations and said the Board all has copies and she would like them to review and should plan to go over recommendations within the next year.

K. Approval: Removal of dead tree in Cate Park

D. Ford addressed the Tree that was taken down 4/6/2022 in Cate Park. The tree had been infected with the Emerald Ash Bora and was a safety issue to the public.
