MINUTES
January 20, 2021
Great Hall, Wolfeboro Town Hall and Virtual Access

Chairman MacDonald opened the meeting at 5:34 pm.

I. Preamble and Roll Call of Members in Attendance

Due to the COVID-19/Coronavirus crisis and in accordance with Governor Sununu's Emergency Order #12 pursuant to Executive Order #2020-04, this Board is authorized to meet electronically. However, the Committee has jointly decided to proceed with a 'hybrid' meeting format allowing for members of the public and Board to attend and participate in the meeting in-person or virtually. In accordance with RSA 91-A: 2, III, the Board has 5 members joining the meeting remotely, which a public body has the authorization to allow.

II. Warrant Articles

Article 25: Milfoil Eradication Public Expendable Trust \$17,000

Jim Pineo read Article 25. He stated the change to the warrant article is a result of NHDRA review; noting NHDRA indicated that Expendable Trust articles require a financial contribution. He stated \$17,000 will be coming from the Milfoil Joint Board to be placed in this account. He noted the BOS recommended the article by a vote of 5-0.

It was moved by Brian Black and seconded by Bob Loughman to recommend Article 25. Roll call vote: John MacDonald – yes, Bob Tougher – yes, Bob Loughman – yes, Steve Johnson – yes, Matt Plache – yes, John Burt – yes, Brian Black – yes. The motion passed (7-0).

Article 26: Wastewater Treatment Plant Capital Reserve Fund \$175,000

Jim Pineo read Article 26; noting the article/contribution to the capital reserve fund was removed by the Town Manager last year in an effort to reduce capital costs by \$125,000. He stated the article was accidentally omitted from the previous presentation.

Steve Johnson questioned the amount in the capital reserve fund based on the October 31, 2020 report from the Trustee of Trust Funds.

Kathy Carpentier provided an updated Trustee of Trust Funds account balance.

John Burt questioned what funding level this account should be at.

Jim Pineo stated the proposed asset management plan will help define such. He stated Dave Ford has a schedule of work.

John Burt stated he does not want to see this fund used for operating and maintenance expenses.

Jim Pineo agreed.

Brian Black questioned the numbering of the warrant articles.

Jim Pineo advised Mr. Black the numbers have changed and the warrant would be finalized on 1/21/2021 and once done, the warrant would be forwarded to the Committee.

It was moved by Bob Loughman and seconded by Matt Plache to recommend Article 26. Roll call vote: John MacDonald – yes, Bob Tougher – yes, Bob Loughman – yes, Steve Johnson – yes, Matt Plache – yes, John Burt – no, Brian Black – yes. The motion passed (6-1).
