The drawings must clearly identify, without limitation, all proposed changes in height; all proposed changes in the width of the structure, taking into account any changes or additions previously made to all appurtenances; all proposed changes to existing equipment; all proposed additional equipment and the proposed location thereof; and, all proposed excavation and other site work.
