The applicant proposes to construct a single family dwelling within the wetland buffer and construct a wetland crossing (3' wide bridge) to construct a gazebo within the wetlands and wetland buffer.

The Wolfeboro Conservation Commission noted no objection to the Judith Oliver/William Iannazzi Special Use Permit application, Tax Map #231-33, as submitted and noted the applicant did as well as could be done considering the limitations of the parcel. The Commission recommends the bridge to the gazebo be constructed prior to the gazebo construction, so that access to the gazebo site could be gained via the bridge instead of repeated crossing of the wetland.

The applicant proposes to construct a single family dwelling within the wetland buffer and a driveway crossing for said dwelling.

The Wolfeboro Conservation Commission noted no objection to the Heirs of Dorothy P. Whittier/William Iannazzi Special Use Permit application, Tax Map #231-32, as submitted and noted the applicant did as well as could be done considering the limitations of the parcel.

The applicant proposes to remove four existing piles under existing crank-up dock and install two pairs of tie-off fender piles for safe 4-way tie off at ends of existing permanent dock structure.

The Wolfeboro Conservation Commission noted no objection to the O'Hare Enterprises, LLC / Nolan Archibald Standard Dredge and Fill application, Tax Map #228-32, as submitted.
