The Town of Wolfeboro Municipal Electric Department will be accepting sealed bids for the purchase of one (1) new: **2021 Chevrolet Colorado/GMC Canyon, (1/2) Ton Extended Cab, 4WD, Standard Bed, Pick-up Truck.**

**Instructions to Bidders:**

- The Town of Wolfeboro Municipal Electric Department intends to purchase a vehicle which meets the specifications provided, however; if it is necessary to bid alternate equipment or to take exception to the specifications stated: *detailed explanations or descriptions of substitutions and/or deviations must be noted in the bid response indicating the item of that specification. This is required in each and every instance where the Wolfeboro Municipal Electric Department's specification is not met.* If no exception details are indicated, it will be assumed that the bidder will furnish the item exactly as specified.
- Prospective bidders must complete the attached **itemized bid form**, and a **signed anti-collusion certificate** completed by an authorized representative of the bidding company.
- All bids must be submitted in an **Envelope** or **E-Mailed** with the subject matter plainly marked;
