POSITION: Ski Patrol/ Ski Rental Manager

DEPARTMENT: Parks & Recreation, Abenaki Ski Area

GENERAL SUMMARY

Provide first aid, rescue services and general customer service at Abenaki Ski Area in Wolfeboro, NH.

ESSENTIAL DUTIES AND RESPONSIBILITIES

- Provide first aid services in a manner consistent with the contents of the National Ski Patrol's Outdoor Emergency Care Course. These services shall be applied according local EMS Protocols.
- Patrol personnel must be capable of skiing or riding a snowboard to any location within the boundaries of the lift serviced area to provide service to a patron. They must also be able to handle a loaded toboggan on any trail or location.
- Patrol personnel are responsible for clean up and snow shoveling in designated areas, boundary maintenance, hazard marking and mitigation and general hill maintenance and clean-up.
- Patrol personnel are responsible for the daily opening and closing of all trails and the terrain park.
- Supervise and schedule other Ski patrollers, supervise staff on mountain for following rules.
- As Abenaki is a small mountain with a small staff, Patrol personnel will assist as needed with lift operation, grilling, opening and closing and other duties as needed.
- Patrollers will do accident investigations and operate snowmobiles and ATV's.
- Responsible for organization of Ski Patrol station and stocking up first aid supplies.
- Ensure that all members of the Patrol must attend annual refreshers required to maintain OEC, CPR, toboggan handling (if required by their level) and lift evacuation certification. Additionally, there will be required ongoing training throughout the ski season at Abenaki to insure that the skills are maintained.
- Each member of the Patrol must recognize that there are inherent risks involved in patrolling. These include, but are not limited to, traumatic injury, contraction of serious diseases, exposure to litigation, injury due to weather, high altitude and other natural conditions and occurrences, etc. Patrollers that maintain a healthy life-style and stay in good physical condition can significantly reduce these risks. Strict adherence to approved policies and procedures will also reduce these risks.
- Patrollers should be taking at least one full mountain run every hour during their shift. This means they should go down every open trail and check for safe conditions of trails, check that patrons are being safe and following rules, and making sure the woods are clear from patrons doing unsafe or illegal activities. If not needed for other details, more than one full mountain run per hour is highly encouraged.
- Responsible for Ski Rentals including organizing rentals, paperwork, maintenance, inventory, etc...

Performs other related duties as requested.

Knowledge, Skills and Abilities

- Must be a strong skier or snowboarder, comfortable on any terrain within Abenaki boundaries.

PHYSICAL DEMANDS

The physical demands described here are representative of those that must be met by an employee to successfully perform the essential functions of this job. Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions.

While performing the duties of this job, the employee is frequently required to stand; walk; sit; use hands to finger, handle, or feel; reach with hands and arms; and talk, see or hear. The employee must regularly stoop, bend, crouch or crawl; climb several flights of stairs, lift and/or move up to 50 pounds. The employee must be able to ride a high speed rope tow unassisted and ski or snowboard on expert terrain with a fully loaded (300+ lbs) toboggan.

The work environment characteristics described here are representative of those an employee encounters while performing the essential functions of this job. Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions.

The employee is regularly exposed to winter outdoor weather conditions.
