Collisions YTD and Accidents by street name: He reported 10 accidents last month a reduction from the previous month.

Traffic stops YTD and location breakdown report: He reported 240 traffic stops last month and 8 tickets were issued out of those stops. Reduction from last month as highway safety grants ending.

Personnel Analysis report: The report is a synopsis of each officer's reporting for the month.

School Resource Officer (SRO): The report summarizes the activity at the Governor Wentworth School complex; possession of tobacco/drug/ alcohol, court appearances, school events, etc. noting it is a very busy campus.

Detectives Report: He provided the Detective's report for review. 8 cases carried over, with 2 new cases for the month. This report has the highest cases closed for the year.
