Bids will be accepted until 2:00pm on Wednesday, April 12th, at which time the bids will be read aloud at Town Hall in the Great Hall at 84 S. Main Street.

Bids should include:

- 1. Total Cost for construction, based on the specifications below. Use the form below to submit costs.
- 2. Proof of Insurance: Worker's Compensation and General Liability (\$1M each occurrence, \$2M aggregate)
- 3. 2 customer references
- 4. At least 2 photographs of recently completed similar projects
- 5. Timeline for project

Feel free to include any additional information that you feel may assist us in awarding this bid such as unique services offered, bulk purchasing discounts, maintenance contracts, etc.

# **Bid Specifications**

Install an ADA Ramp and Railings in Cate Park

#### **Preparatory Work**

- Removal of existing area landscape.
- Lay a base for ramp.

#### New Work

- Install a 45 foot long, 6 foot wide ramp starting from sidewalk entrance to the northwest corner entrance to Cate Park.
- Ramp should start with a platform off the walkway that exists.
- Install an ADA railing with grab handrails on both sides of the ramp.
- Should be a gradual decline to the lower level of the park.

#### Notes

- Work cannot interfere with events in the park; completion date to be no later than the first week in June 2023.
- Work around/with other projects happening in the park
- The ADA ramp and railings should be constructed of similar materials to compliment the parks improvements over the years.
