## DEATH OR HOSPITALIZATION OF AN EMPLOYEE

### **Purpose**

To provide appropriate emotional care for the seriously injured, ill, or deceased employee's family.

## **Policy**

It shall be the responsibility of the Wolfeboro Police Department to provide liaison assistance to the primary family of an officer who:

- Dies in the line-of-duty
- Is hospitalized for an indefinite period
- Or requires repeated and/or intermittent hospitalization because of a line-of-duty injury or systemic illness

This assistance shall include, but not limited to, the clarification and comprehensive study of survivor benefits and emotional support during this traumatic period for the family.

### **Definitions**

*Line-of-Duty Death*: Any action, felonious or accidental, which claims the life of an Wolfeboro Police Officer who is performing work related functions either while on or off-duty.

*Line-of-Duty Injury or Illness*: For the purpose of this policy, a line-of-duty injury or illness shall be an injury.

*Survivors*: Primary family members of the injured or deceased officer, including spouse, children, grandchildren, parents, grandparents, siblings, fiancé, and/or significant others.

**Beneficiary:** Those designated by the officer as recipients of specific death benefits.

**Benefits:** Financial payments made to the family to assist with financial stability following the loss of a loved one.

**Funeral Payments:** Financial payments made to the surviving families of an officer killed in the line-of-duty, which are specifically earmarked, for funeral expenses.

## Notification of Chief

The Chief and Captain shall be notified of the death or hospitalization of a member immediately and a designee appointed as a liaison.

Under no circumstances should the name of the deceased member be released to the media before the immediate family is notified

# Notification to the Family

The following steps should be made, if applicable, in notifying family of the death or hospitalization of a member:

whenever possible. If the media has somehow obtained the officer's name, they should be advised to withhold the information, pending the notification of the next of kin.

## Assistance for **Affected Officers**

- Officers who were on scene or who arrived after an officer was critically injured or killed should be relieved as soon as possible
- Police employees who may have been emotionally affected by the serious injury or death of another officer should be referred to counseling.

## **Family Assistance at** the Hospital

A hospital liaison shall be designated. The hospital liaison is responsible for coordinating the activities of hospital personnel, the officer's family, police officers, the media, and others. These responsibilities include:

- Arrange with hospital personnel to provide for appropriate waiting facility for the family, the Chief of Police, the notification officer, and only those others requested by the immediate family.
- Arrange with the hospital personnel to provide a separate area for fellow officers and friends to assemble.
- Arrange with hospital to provide a media/press area.
- Work with medical personnel to relay pertinent information regarding an officer's condition to the family on a timely basis and before such information is released to others.
- Ensure that the family is updated regarding the incident and the officer's condition upon their arrival at the hospital.
- Arrange transportation for the family back to their residence

The notification officer(s) should remain at the hospital while the family is present and assist them in any way possible

## Support of the **Family During the** Wake or **Funeral**

The Chief of Police, or a designee, will meet with the officer's family to determine their wishes regarding departmental participation or assistance in the preparation of the funeral or services. All possible assistance will be rendered.

## Continued **Support for** the Family

The department liaison officer acts as a long-term liaison with the surviving family. The department liaison officer ensures that close contact is maintained between the department and the survivors and that their needs are met for as long as they feel the need for support. Members of the department are encouraged to reach out to the family, and

they should be included in department activities and functions, if possible.
