# **DWI GUIDELINES**

**Policy** To establish procedures for DWI cases and arrested subjects.

**Definitions** 

**BAC:** Blood Alcohol Concentration. The percentage of alcohol in blood.

*Divided Attention:* Test: Requires the subject to concentrate on both mental and physical tasks at the same time.

**DWI:** Driving While Intoxicated or Driving While Impaired. Driving a vehicle while under the influence of alcohol or drug(s).

*Field Sobriety:* Test: Any one of a series of roadside tests that can be used to determine whether a suspect is impaired.

*HGN:* Horizontal Gaze Nystagmus. A field sobriety test based on the jerking of the eyes as they gaze toward the side.

Nystagmus: An involuntary jerking of the eyes.

One Leg Stand (OLS): a divided attention field sobriety test.

Standardized Field Sobriety Test Battery: a battery of three field sobriety tests, HGN, Walk and Turn, and One Leg Stand, administered and evaluated in a standardized manner to obtain validated indicators of impairment based on NHTSA research.

Walk and Turn (WAT): a divided attention field sobriety test.

General Procedures When an officer makes contact with a driver because of

- A motor vehicle violation stop.
- Driver involved in an accident.
- Or has articulable suspicion to stop a motor vehicle.

#### SOP 3.10 DWI Guidelines

The three senses should be used to detect alcohol or drug influence.

- SIGHT
- HEARING
- SMELL

The physical observations may show indications of intoxication This justifies further investigation.

The driver can then be subject to further investigation in or outside of the vehicle.

## Field Sobriety Tests

Standardized Field Sobriety Tests will assist with the decision to arrest or release the driver.

#### Walk & Turn

It is a divided attention test consisting of two stages:

- 1. Instruction stage.
- 2. Walking stage.

Stage	Description
Instruction	Subject must stand on a line with feet in heel to toe position,
	keep arms at sides,
	and listen to instructions.
	The instruction stage divides the subject's attention between
	a balancing task and an information-processing task.
Walking	Subject must take nine heel to toe steps down a line,
	turn in the prescribed way,
	and take nine heel to toe steps back up a line
	while counting each step out loud.
	During the turn, the subject must keep the front foot on the
	line, turn in the prescribed manner, and use the other to take several small steps to complete the turn. The walking stage
	divides the subject's attention among a balancing task, a small muscle control task, and a short-term memory task. If a
	line is not available, then the Officer may use a simulated
	line

### **One Leg Stand**

It is a divided attention test consisting of two stages:

- 1. Instruction Stage.
- 2. Balancing and Counting Stage.

Stage	Description
Instruction	Subject must stand with their feet together,
	keep arms at the sides,
	and listen to instructions.
	This divides the subject's attention between a balancing task
	and an information-processing task.
Balancing	Subject must raise one leg approximately six inches off the
and	ground, toes pointed out, keeping both legs straight.
Counting	While looking at the elevated foot, count out loud for 30
	seconds in the following manner: "one thousand one, one
	thousand two", until told to stop.
	This divides the subject's attention between balancing and
	small muscle control.

## Horizontal Gaze Nystagmus

Only Officers that have been trained and certified to use HGN are authorized to use this as a field test.

## Vertical Nystagmus

Only Officers that have been trained and certified to use VG are authorized to use this as a field test.

### **Seated Test**

Can be employed if the Driver is physically unable to perform the standard field test – due to handicap or other illness – all or some.

Step	Action
1	Asking for two things simultaneously such as a driver's license and
	registration
2	Asking interrupting or distracting questions;
3	Asking unusual questions such as what their middle name is.
4	Ask the driver to recite the alphabet using their normal tone of
	voice. Demonstrate how you want the driver to respond.
5	Ask the driver to count down from a larger number such as 63 to a
	smaller number such as 42. Avoid using number sequences that
	start or end in increments of 5; they are too easy to remember.
6	Ask the driver to count fingers. The driver is asked to touch the
	tip of the thumb in turn to the tip of each finger on the same hand
	while counting up 1, 2, 3, and 4; then reverse direction on the
	fingers while counting down.

#### Arrest

If the officer has probable cause for a DWI case.

No person shall be charged with a lesser offense if probable cause exists for DWI.

Officers shall have dispatch obtain a record check on the subject.

### **Processing**

Shall be in accordance with SOP's as well as the additional steps.

1	Read and explained the ALS Rights – on ALS Form
2	If driver consents to the test
3	Certified Intox 5000 operator will administer the test
	At Wolfeboro PD or if not functioning at another agency where
	one is located
	Legal limit for DWI 0.08 for drivers over 21, 0.02 for drivers
	under 21and Commercial M/V 0.04
4	Drivers refusal – seize the <b>NH</b> drivers license and enclose it in the
	ALS form
	Required sections filled out
	Pink copy of ALS issued to driver as temporary license
	Out of State driver, pink copy does not need to be issued
5	Photograph the subject
6	If blood is drawn, the officer shall seal the blood sample and
	complete all applicable forms within the canister provided by the
	NH Dept of Health. Documented in file

## Felony DWI

If the subject is being charged with a felony.

- ALS Felony form shall be used.
- Driver informed that they do not have the right to refuse.
- If necessary blood may be drawn forcibly Chief of Police and Carroll County Attorney should be contacted first.

Arrest Forms	All computer-generated forms are to be completed at the
	time of arrest. Unless Supervisor approves extension
Intoxilizer	Form filed out by certified officer
