COMMUNICABLE DISEASES

Policy To reduce risks and protect members from contracting a communicable

disease.

Definitions Airborne Disease: spread by contact with droplets of the disease producing

organism which have been expelled into the air by cough, sneeze or direct

contact of respiratory secretions.

Biohazard: Biological material, especially if infectious, that poses a threat to

humans and/or their environment.

Body Fluids: Fluids that the body makes or replenishes including, but not

limited to blood, semen and secretions.

Communicable Diseases: A disease that can be transmitted from one person to another, such as:

- 1. Acquired Immunodeficiency Syndrome. (AIDS)
- 2. Human Immunodeficiency Virus Infection.
- 3. Chickenpox.
- 4. Diphtheria.
- 5. Haemophilus Influenza Infection.
- 6. Hepatitus, A, B, Non A, and Non B.
- 7. Malaria.
- 8. Measles (Rubeola).
- 9. Meningococcal Disease.
- 10. Pertussis.
- 11. Rabies.
- 12. Rubella.
- 13. Syphilis.
- 14. Tuberculosis.

Contaminated: Contact with bodily fluids, including those that may be airborne.

Immunization: procedure by which a person is rendered immune *Medical Referral Consultant:* An employee's primary healthcare physician or an area hospital.

Potential Carrier: All persons need to be considered.

Source Individual: Any person whose blood, body fluids, airborne secretions, tissue or organs were specifically identified as the source of exposure. **Unprotected Exposure:** Instances of direct mouth to mouth resuscitation, commingling of blood or other potential infectious material of a source individual and public safety worker, which is capable of transmitting a communicable disease or any other such type of exposure.

Exposure Control

The following procedures shall be utilized by members of the department for safety.

Washing	If contact is made, wash affected areas with antiseptic cleaner under warm, running water ASAP. If not available, use an antiseptic hand cleaner with antiseptic towelettes or clean paper towels. Wash again when practical.

Post Exposure

Member shall:

- Report to Hospital as soon as possible.
- File a Workmen Compensation Report within 48 hours.
- If the source individual is known, notify the hospital and request that a test for HIV be conducted. (if the person consents)
- If the source is diagnosed to have a communicable disease which is transmitted by unprotected exposure under RSA 141 G:5, the medical facility must notify the member, verbally, within 48 hours & in writing within 73 hours.
- Any information received by the department is confidential.

Source Infected

Member shall

- Be medically evaluated and treated.
- Counseled regarding any risk.
- If tested negative should be retested as deemed necessary by a physician.
- If source cannot be identified appropriate follow –up shall be handled on a case by case basis.

SOP 6.16 Communicable Diseases

Reports

- Whenever exposure is made as soon as possible. (within 24 hours)
- Notification to the chief of the circumstances within 48 hours.
- On the job injury report as soon as possible.
