Mutual Aid	Exist with our neighboring jurisdictions under RSA 105:13 and 48:11-a for the purpose of providing Mutual Extended Authority. The Chief may also request non-emergency assistance from another agencies under RSA 48:11-A or RSA 105:13	
Procedures	 An officer may request assistance and must: Advise responding officers what assistance is necessary. Detail in a report the nature of the request, names and actions of all personnel. All responding units should utilize the Wolfeboro radio frequencies. Terminate the assistance as soon as it is no longer required. If request to assist another jurisdiction the officer shall: Comply with the request if possible, provided no emergency request in Wolfeboro goes unattended. Officers shall assist as needed, but at no time shall they obey any unlawful or improper order. Detail the nature of the incident and assistance in a report. In cases where it involves extensive loaning of manpower and equipment the Chief will be notified for authorization. 	
Federal Agencies	 In cases where it is necessary to request assistance from a Federal Law Enforcement Officer, other then for routine inquiries: A supervisor will be appraised of the situation in non-emergency situations. In an emergency situation the Chief or Captain/Executive Officer will be notified. The request will be made through that agencies proper channels. 	
National Guard	 In the event of an emergency that requires the National Guard: The Chief will evaluate the situation and determine what resources are needed. The Chief will then make a request to the Governor. If the Guard is activated, the Chief will be the Liaison Officer to coordinate all joint Law Enforcement activities until the emergency no longer exists.
