CEMETERY RULES AND REGULATIONS

- The sale of cemetery lots in Wolfeboro Town Cemeteries shall be restricted to buyers who are current or past residents of the Town of Wolfeboro. Resale of cemetery lots is strictly prohibited. Lot owners may return unwanted or unneeded lots to the Town either by donation or for compensation in the same amount as the owner paid for the lot.
- For every interment (except urns), the use of a concrete liner or concrete vault shall be required.
- Burials in each grave may consist of one of the following: (1) one traditional casket; (2) one traditional casket and one cremain urn; (3) a mother and infant in one casket; (4) two infants in one casket; and (5) two cremain urns. No animals shall be buried in Town Cemeteries.
- Payment for the purchase of new cemetery lots shall be made payable to the Town of Wolfeboro in the amount of \$1,000 per lot.
- For every interment, including urns, the attending Funeral Director or family should complete and submit a Town of Wolfeboro Grave Activity Report to the Town Manager' office along with a \$100 fee payable to the Town of Wolfeboro.
- Not more than one upright monument shall be placed on any one plotted lot of four or more contiguous grave sites belonging to one owner. All monuments shall be set in the ground on a concrete foundation, but such foundation must not project above ground level.
- Individual grave site markers may be flush to the ground, or vertical headstones may be set in the ground on a secure foundation to be constructed to a proper depth considering the consistency of the soil at the grave site. If corner markers are desired, the markers shall be placed at the four corners, but must not project above ground level.
- No shrubs, plants, or trees shall be planted near grave sites. Any shrubs, plants, or trees
 planted without such approval are subject to removal by the Town.
- A few flowers or floral arrangements may be placed at each grave markers, headstones, or monuments in such a way that they are not an obstruction to mowing operations. The Town reserves the right to remove wilted flowers and floral arrangements that have surpassed their seasonal purpose.
- Grounds maintenance of cemetery lots will be provided under the supervision of an at the expense of the Town.
- The placing of anchor wires, wires that protrude from the ground or wiring of any kind is not permitted, with the exception of veterans markers and flag stands. No permanent source of flame is allowed (i.e. gas, kerosene, etc.)
- The placing of boxes, shells, toys, metal, balloons, designs, ornaments, chairs, settees, loose stones, vases, and similar articles upon plots is not permitted and if so placed, the Town reserves the right to remove them. Neither are skateboards, manual scooters, off-road vehicles, and the like permitted to be used in Town cemeteries.

- Driving of any unauthorized motor vehicle across or upon any grave or grave plot, or parking the same thereon, is prohibited.
- Persons visiting the cemetery with a pet must have the pet leashed and within their control and be responsible for any waste removal if left by pets.
- For exhumations, all cost are the responsibly of the family or petitioning authority to open and close.
